

## Maintenance Operative/ Technician

### Main Purpose of Job:

- To ensure smooth running and operation of the plant and equipment within the nurseries including glasshouses and buildings maintenance. To maintain existing equipment and to install / help to install new equipment.
- Cleaning and servicing of all tools for the Packaging Automation machines.
- Helping on machine dismantle for repairs and production lines.
- Checks of all packing machines and production lines.
- General maintenance of the Packhouse, i.e. painting of walls/floors, repairs of any fixtures and fitting.
- Any other duties as reasonably requested.

### Key Accountabilities and Responsibilities:

- Time planning and control: plan work on a daily basis; assist planning of work for a weekly/longer term basis; assess breakdown and plan; accordingly, prioritise jobs/breakdowns; liaise with other departments to enable repairs to be carried out at times acceptable to both parties.
- Administration: use appropriate paperwork; keep track of orders; keep track of stock levels (e.g. fuels, materials); work within budgeted limitations; keep records in accordance with the current Company's Policies and legal/audit requirements.
- Operational requirements: be aware of other departments' requirements; maintain high level of service to the departments/customers.
- Quality of work: ensure that the work carried out by the department is of acceptable standards.
- Technical: be conversant with the necessary skills to carry out the work the job holder is involved with; be conversant with nursery machinery, basic harvest, etc.; be aware of new techniques and equipment.
- Any other duties as reasonably requested.
